A. Hospital Visit and Critical Care on Same Day When a hospital inpatient or office/outpatient evaluation and management service (E/M) are furnished on a calendar date at which time the patient does not require critical care

### CMS Manual System

Since critical care is a time-based code, the physician's progress note must contain documentation of the total time involved providing critical care services. Critical care codes 99291 (evaluation and management of the critically ill or critically injured patient, first 30-74 minutes) and 99292 (critical care, each additional 30 minutes) are used to report the total duration of time spent by a provider providing critical care services to a critically ill or critically injured patient ...

COVID-19: Patient Visitor Guidelines Currently, Penn Medicine has protocols in place to maximize the safety of all who enter our hospitals and facilities. These safety protocols include limiting visitors to accompany patients to appointments or see them in the hospital.

The guidance directs nursing homes to restrict visitation except in certain compassionate cases, like end-of-life. In those cases, visitors will be equipped with personal protective equipment (PPE) like masks, and the visit will be limited to a specific room only.

### Guidance - California Department of Public Health

To avoid overwhelming the patient and to allow our staff to safely perform patient care, Chester County Hospital has set the following Visitor Guidelines for the Critical Care Unit (CCU): Only two visitors at a time. No children under the age of 13 are permitted in the CCU. This is for their protection and for the protection of our patients.

Remember: Split/shared visits do not apply to consultations (99241-99255), critical care services (99291-99292) or procedures. Relationship to Incident-to. To bill a split/shared visit in the physician office setting, the visit must meet incident-to rules.

### Medicare's Split/Shared Visit Policy - AAPC Knowledge Center

This Pilot Visitation Program at NYP is effective Friday, June 19, 2020. The visitor must: Be limited to one adult person per visit. Undergo temperature and symptom screening upon arrival\*. Perform hand hygiene and wear appropriate personal protective equipment at all times.

### COVID-19 General Visitation Guidelines & Visitor Policy ...

Patients appreciate a quiet hospital. Try to limit the number of visitors to one or two people at a time. Ask your loved one how long they want visitors to stay; don't stay too long and tire them out too much. Also, don't assume that your loved one would prefer to not have visitors. Ask them what they want and need.
