Legal Definition of not guilty by reason of insanity. 1 : a plea by a criminal defendant who intends to raise an insanity defense —used in jurisdictions that require such a plea in order for an insanity defense to be presented. 2 : a verdict rendered by a jury in a criminal case that finds that the defendant was insane at the time of committing the crime as determined by application of the test for insanity used in the jurisdiction — compare guilty but mentally ill.

Many television and movie defendants are found not guilty by reason of insanity. However, real criminal defendants are not as successful with the insanity defense as popular media seems to suggest. One study found that the insanity defense is only used in about 1% of all court cases and is only successful in about 26% of those cases.
