This training program is now available online on the Georgia Professional Certifications website.

Under the new label, only certified applicators who have a pesticide license and have completed this training will be able to load, mix, and/or apply paraquat. No longer will persons under the direct supervision of a certified applicator be able to use the product. The training will have to be completed once every 3 years.
